We are pleased to sponsor the 34th Annual Art Festival associated with "Dancin' in the Street" in Neptune Beach on Saturday, May 16, 2020. Artists set up in the 100 and 200 blocks of First Street and Lemon Street in Neptune Beach. **The entry fee is \$100.00 for a 10 x 10 space. Please make checks payable to "Beaches Town Center Agency". All works displayed and for sale must be original works or prints of original art or crafts made by the displaying artist.** This is not a juried art show. No more than two artists may exhibit and sell their art per booth. Entries are accepted on a first come, first serve basis. Space assignments are made in the order entries are received. We have 48 artist spaces. **The deadline for submitting applications is postmarked by Friday, May 1, 2020** If you request a specific space, please apply **EARLY** and note request on application form.

**All entries must include photographs of the artist's works. Please do not send slides.** "Dancin' in the Street" has final approval on all artists. **NO PIPES OR ANY OTHER DRUG PARAPHENALIA or DRUG ART ARE ALLOWED TO BE SOLD OR DISPLAYED.**

Vendors are responsible for collecting and submitting the appropriate sales tax to the State of Florida.

**Upon Acceptance your check is cashed and you will receive an email with your space assignment along with a map. If you are not accepted, we will promptly mail your application and check back to you.**

**Set up/Check In: 7:00 a.m.** in the 200 block of Lemon Street in Neptune Beach. Please do not show up before 7:00 a.m. on show day unless you intend to wait patiently. Spaces are assigned before arrival and showing up early will not change your space.

The music on the Ocean Stage begins at noon and the Orange Street Stage begins at 11:30 am. All artists breakdown is 8:00 p.m. No vehicles will be permitted into the streets prior to the end of the festival. Reminder: No electricity is provided.
